I confirm the Authorization Number, if applicable, from the volunteer organization's letter is being used by me for the volunteer organization and position to which it was assigned. I have read this consent, understand it and agree to it in its entirety. I acknowledge there are no refunds for Police Record Check fees.
- I hereby consent to a search being made in the automated criminal records retrieval system maintained by the Royal Canadian Mounted Police to determine if I have been convicted of, and been granted a record suspension for any of the offences that are listed in the Schedule(s) to the Criminal Records Act.
- I understand that, as a result of giving this consent, if my date of birth and gender is a possible match to the person named in a criminal record for one of the offences listed in the Schedule(s) to the Criminal Records Act in respect of which a record suspension was granted or issued, I will be requested to provide fingerprints to confirm that record and that record may be provided by the Commissioner of the Royal Canadian Mounted Police to the Solicitor General of Canada, who may then disclose all or part of the information contained in that record to a police service or other authorized body. That police service or authorized body will then disclose that information to me. If I further consent in writing to the disclosure of that information to the person or organization referred to above, that requested the verification, that information will be disclosed to that person or organization.

- Criminal convictions and summary convictions from CPIC and/or local databases.
- Findings of guilt under the Youth Criminal Justice Act within the applicable disclosure period.
- Outstanding entries such as Charges and Warrants, Judicial Orders, Peace Bonds, Probation and Prohibition Orders.
- Absolute and conditional discharges.
- In exceptional cases, where Exceptional Disclosure Assessment factors are met, non-conviction dispositions including but not limited to Withdrawn and Dismissed.
- Not Criminally Responsible by Reason of Mental Disorder.
- All record suspensions as authorized for release by the Minister of Public Safety.
